Ordinance No. 2021-14Passed May 27,, 2021

## AN ORDINANCE ESTABLISHING THE RATES FOR THE VILLAGE OF SABINA SWIMMING POOL AS AN EMERGENCY MEASURE

**WHEREAS** the Village of Sabina owns and operates a pool for the benefit of the public;

**WHEREAS** the Village seeks to set the rates of admittance to the pool;

**NOW, THEREFORE, BE IT ORDAINED** by the Council of the Village of Sabina, Clinton County, Ohio three-fourths or more of the members of the council elected thereto concurring that:

### Section 1: Seasonal Price of Pool Pass

- A. Splash Pass (7): \$30 each
- B. Single Pool Pass: \$125
- C. Double Pool Pass: \$175
- D. Family Pool Pass: \$225
- \*Extra family member \$10 with purchase of a family pass

**Section 2:** Any single, double or family pool pass purchased on or before June 3, 2021 shall be discounted at a rate of 50 percent. This discount does not apply to the extra family member charge.

**Section 3:** Daily passes will be \$5.50 per day until 5:00 pm at which time a daily pass will change to \$2.75

**Section 4:** Private pool parties will be at a cost of \$200 for up to 70 people and \$250 for parties greater than 70 people for the first two hours. After the first two hours, there will be an additional \$50 per hour. A security deposit of \$50 is required to schedule the event and will be applied to the total balance. Balance must be paid in full before the event begins

**Section 5:** Children under the age of 12 years old must be accompanied by an adult at all times. An adult must be age 18 or older.

### Section 6: Definitions

- A. Single: One person over the age of two years old.
- B. Double: Two people over the age of two years old residing in the same household.\*
- C. Family: Two parents and/or legal guardians and up to four unmarried children over the age of two and under the age of twenty-one who reside in the same household.\*
- D. Extra Family Member: Seven or more purchasing a family pass, under the age of twenty-one, and residing in the same household.
- \*Proof of residence shall be required.

**Section 6:** There will be a 10% discount given to any military, first responder, senior, or employee to the purchase of a daily pass.

**Section 7:** All passes are non-refundable.

**Section 8:** This is Emergency Ordinance, necessary for the immediate preservation of public peace, health, and safety of the and shall go into effect immediately upon passage.


