	WHEREAS the Village of Sabina owns and operates a pool for the benefit of the public and;	
	WHEREAS the Village seeks to set the rates of admittance to the pool and;	
	NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Sabina, Clinton County, Ohio two-thirds or more of the members of the council elected thereto concurring that:	
	 Section 1: Definitions A. Single: One person over the age of two years old. B. Double: Two people over the age of two years old residing in the same household (includes non-resident caregiver) C. Family: Two parents and/or legal guardians and up to four unmarried children over the age of two and under the age of twenty-one who reside in the same household (includes non-resident caregiver) D. Extra Family Member: Seven or more purchasing a family pass, under the age of twenty-one, and residing in the same household. 	
	Section 2: Seasonal Price of Pool Passes A. Splash Pass (7): \$35 each B. Single Pool Pass: \$125 C. Double Pool Pass: \$175 D. Family Pool Pass: \$250 *Extra family member \$10 each with purchase of a family pass	
	 Section 3: Discount Schedule: A. Beginning December 1st, 2023, any single, double, or family pool pass shall be discounted at a rate of fifty percent (50%). Said passes shall remain discounted at a rate of fifty percent through January 31, 2024. B. Beginning February 1, 2024, any single, double, or family pool pass shall be discounted at a rate of twenty-five percent (25%). Said passes shall remain discounted at a rate of 	

- twenty-five percent through March 31, 2024.
- C. Beginning April 1, 2024, all passes shall be sold at their full price.
- D. These discounts do not apply to the extra family member charge.

section 4: Price for Daily Admission (non-passholders)

- A. \$6.00 for entry (unless after 5:00 pm)
- E. \$3.00 for entry after 5:00 pm
- C. \$3.00 for non-swimmer admission (unless after 5:00 pm)
- D. \$2.00 for non-swimmer admission after 5:00 pm
- E. The late price admissions on Sundays will begin at 4:00 pm

Section 5: Lawn chairs are available for rental at the rate of \$5.00 per visit. Upon return of the chair the patron shall receive \$2.00 back from the \$5.00 already paid.

section 6: Private pool parties will be at a cost of \$250 for up to 70 people for two hours and \$300 or parties greater than 70 people for the first two hours. After the first two hours, there will be an dditional \$100 per hour. A non-refundable deposit of \$150 is required to schedule the event and will be applied to the total balance. Balance must be paid in full before the event begins

section 7: Public pool parties (parties during business hours and open to the public) shall be available at two rates.

Ordinare Fall Day (6 hours from 2:00 pm – 8.00 pm) public pool party: \$750.00 including a \$250 deposit applied to the total balance. A full day on Sunday shall be from 12:00 pm – 6:00 pm

B. Half Day (4 hours) public pool party: \$400.00 including a \$150 deposit applied to the total balance.

Section 8: A Small Party (less than or equal to 20 persons) may reserve a section of the shelter house during business hours at a rate of \$50.00 per hour.

Section 9: Children under the age of 12 years old must be accompanied by an adult at all times. An adult must be age 18 or older.

Section 10: There will be a 10% discount given to any military, first responder, senior, or Village employee to the purchase of any full price seasonal pass.

Section 11: All passes are non-refundable.
