

Ordinance No. _____ Passed June 27, 13, 2013

AN ORDINANCE VACATING AN ALLEY

Whereas, on June 13, 2013 petitioners Peggy Sloan and Nancy Browning presented a petition for the vacation of an alley between said petitioners.

Whereas, the petitioners are all of the parties abutting said alley in question, and

Whereas, no public notice then need be given, and

Whereas, said alley has not been in use for public access for a great number of years, and the Village has not maintained said alley,

THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF SABINA, CLINTON COUNTY, OHIO:

Section One: The alley running between the properties of Peggy Sloan, a vacant lot, Parcel # 250060326001400 on Sherman Street, being Lot No. 14 of the Village of Sabina, and Nancy Browning, 80 Sherman Street, being Lot No. 13 of the Village of Sabina, be and hereby is vacated from public use.

Section Two: Any public utility easement on said alley shall remain in full force.


Section Three: The fiscal officer shall cause a certified copy of this ordinance to be recorded in the office of the Clinton County, Recorder, and the petitioners shall pay such costs as well as the publication costs herein.

This ordinance shall be in full force and effect from and after the earliest period allowed by law.
