AN ORDINANCE INCREASING THE WAGES OF NANCY L. CORNELL, FISCAL OFFICE, OF THE VILLAGE OF SABINA, CLINTON COUNTY, OHIO AND DECLARING AN EMERGENCY.

WHEREAS, the Village Council wishes to increase the wages of Fiscal Officer, Nancy L. Cornell hourly rate from \$15.44 per hour to \$16.21 per hour, which represents an increase of \$0.77 per hour;
